Job Description

The duties of this position include, but are not limited to:

- Review and analyze financial statements and financial information to assess overall utility management, financial performance, and adequacy of current and proposed pricing structures (cost of service, financial forecasting).
- Performance of advanced financial analysis and preparation of financial models with user-friendly dashboards to improve flexibility in decision making addressing our clients' most challenging problems.
